Organizational setting and Reporting:

This position is located in the External Relations Office, Registry. The incumbent reports directly to the External Relations Officer.

Responsibilities:

- Assists the External Relations Officer in planning and developing of public information and outreach campaigns and projects.
- Within limits of delegated authority and together with the External Relations Officer monitors the public trends towards the Mechanism and determines possibilities for new engagement possibilities with a variety of partners, both international and from the former Yugoslavia.
- Develops together with the External Relations Officer and other team members, project proposals, methodology, materials, procedure and work plans, work schedule and priority list, quarterly and progress reports, internal reviews, briefings, presentations etc.
- Analyses and maintains an overview of the work, ensures that adequate support is provided for timely delivery of all project tasks.
- Ensures project implementation and products are in compliance with agreements with donors and project partners.
- Within delegated authority, seeks funding opportunities and compiles project proposals and budget and resource requirements with other relevant sections within the Registry.
- Trains, supervises and monitors compliance of project staff with reporting and project requirements, both in The Hague and in the Field Office.
- Maintains policy, standard operating procedures, general management files, contract documents, contract compliance and other project documentation, as required.
- Contributes to the preparation of status and progress reports by maintaining databases capable of providing pertinent information.
- Fulfills speaking engagements and makes presentations to groups on Mechanism work and activities, and advocates issues of concern.
- Assists in organisation of seminars, lectures, conferences, public events on major issues and events concerning the Mechanism.
- Effectively meets challenges and risks.

Core Competencies:

- **Professionalism:** Outstanding knowledge of project management, implementation procedures, creation of work plans and progress and project reports. Possesses a good knowledge of the Mechanism's work and functioning, its achievements and goals, as well as of the legacy of the International Criminal Tribunal for the former Yugoslavia. Good understanding of approaches, tools and methodologies related to planning, executing and monitoring communications campaigns. Demonstrated skills in strategic planning, communication and resource mobilization skills, including the ability to persuasively express section and institutional goals in project proposals. Proven excellence in written and oral presentation skills. Strong team building and personnel management skills. Will be expected to demonstrate a high degree of self-reliance and motivation working to a significant degree without close supervision. Commitment to implementing the goal of gender equality by ensuring the equal participation and full involvement of women and men in all aspects of work. Shows pride in work and in achievements. Demonstrates professional competence and mastery of subject matter. Is conscientious and efficient in meeting commitments, observing deadlines and achieving results. Is motivated by professional rather than personal concerns. Shows persistence when faced with difficult problems or challenges. Remains calm in stressful situations.

QUALIFICATIONS

Education:

Advanced university degree in communications, journalism, public relations, politics, humanities or similar field. A first level university degree in combination with two additional years of qualifying experience may be accepted in lieu of an advanced university degree.

Experience:

Minimum of 2 years of progressively responsible experience in the field of project management or communications. Experience with the UN or other international organisation is desirable. Experience and success in the management and monitoring of external and internal communication projects and in planning and implementation of programmes also desirable. Knowledge of UN rules and guidelines related to project management and financial expenditures highly desirable.

Language:

English and French are the working languages of the Tribunal. For the post advertised, fluency in oral and written English is required. Knowledge of Bosnian/Croatian/Serbian (BCS) is an advantage.

Assessment Method:

There may be a technical test and competency-based interview.

Special Notice:

Current UN staff at the GS and FS level who meet the eligibility requirements are exceptionally permitted to apply. If selected, certain conditions will apply. All offers of appointment are subject to budgetary approval.

The appointment is limited to the International Residual Mechanism for Criminal Tribunals. Appointment of the successful candidate on this position will be limited to the initial funding of the post. Extension of the appointment is subject to the extension of the mandate and/or the availability of funds. As the international tribunals are not integrated in the Secretariat, UN Staff Members serve on assignment or secondment from their parent department/office if selected. Appointments of staff members in the United Nations are subject to the authority of the Secretary-General. Staff Members are expected to move periodically to new functions in accordance with established rules and procedures, and may in this context be reassigned by the Secretary-General throughout the Organization based on the changing needs and mandates.

United Nations Considerations

According to article 101, paragraph 3, of the Charter of the United Nations, the paramount consideration in the employment of the staff is the necessity of securing the highest standards of efficiency, competence, and integrity.
