

On the Classification:

1. The present motion has been filed confidentially as it refers to documents that are themselves confidential [REDACTED].

I. Procedural History:

- 2. On 20 December 2023, going through the Mechanism's Registry, the Defence filed an application for admission with the French Authorities.
- 3. On 28 February 2024, the French Embassy in the Netherlands informed the Mechanism by note verbale that France had refused Félicien Kabuga's application for admission.
- 4. On the same day, the Defence was informed by the Mechanism's Registry of the refusal of Félicien Kabuga's application for admission into France.
- 5. On 19 July 2024, following several exchanges between the Defence, the Chamber and the French Authorities, Félicien Kabuga filed a motion before the Paris Administrative Court to vacate the decision to refuse him admission.
- 6. On 17 June 2025, oral arguments were heard before the Paris Administrative Court.
- 7. During the oral arguments of 17 June 2025, the French administration maintained before the Paris Administrative Court that Félicien Kabuga's refusal was an act of government because the issue pertained to the direct relationship between the French Authorities and the Mechanism. Therefore, in the administration's view, Félicien Kabuga could not challenge this refusal.
- 8. With regard to the French specialist, during the same oral arguments of 17 June 2025, he explained to the Paris Administrative Court that there had been a misunderstanding over the subject of the dispute: as was his right, Félicien Kabuga was asking the French Authorities for permission to [REDACTED].

- 9. In its judgement of 1 July 2025, the Paris Administrative Court dismissed Félicien Kabuga's request, deeming that the refusal of admission constituted an act of government.
- 10. On 29 August 2025, Félicien Kabuga submitted an appeal against this decision in a motion filed the same day.
- 11. On 1 September 2025, Félicien Kabuga's appeal was registered by the Paris Administrative Court of Appeal.

 - ii. The Independent Medical Expert's report dated 18 April 2025;
 - iii. Further submissions from the Independent Medical Expert, filed on 23 June 2025;
