FOLLOWING INITIAL APPEARANCE" OF 25 NOVEMBER 2020
AND THE "ORDER AMENDING THE MEDICAL REPORTING
REGIME" OF 25 SEPTEMBER 2023**

1. Pursuant to Rule 31(B) of the Rules of Procedure and Evidence of the International Residual Mechanism for Criminal Tribunals (“Mechanism”), the “Order Following Initial Appearance” of 25 November 2020 (“Order of 25 November 2020”),¹ and the “Order Amending the Medical Reporting Regime” of 25 September 2023 (“Order of 25 September 2023”),² I respectfully file this submission.
2. In the Order of 25 November 2020, the Pre-Trial Judge considered that “the Registrar should continue to regularly submit reports on [Mr.] Kabuga’s on-going medical examinations in order to facilitate the expeditious scheduling of pre-trial preparations, and, in particular, provide the information necessary to evaluate the Accused’s fitness to travel to the Arusha Branch of the Mechanism”.³ The Pre-Trial Judge ordered the Registrar “to submit medical reports regarding [Mr.] Kabuga’s health and on-going medical assessment every 14 days”.⁴
3. In the Order of 25 September 2023, the Trial Chamber amended the medical reporting regime and “order[ed] the Registrar to submit medical reports regarding Mr. Kabuga’s health once a month, specifically the third Thursday of each month, or as soon as possible should there be any significant medical developments.”⁵
4. In fulfilment of the above, I convey the attached medical report in annex regarding Mr. Kabuga’s health, prepared by the Reporting Medical Officer of the United Nations Detention Unit.⁶
5. I remain available should the Trial Chamber require further information.
