**REGISTRAR'S NOTICE OF
RECOGNITION OF *PRO BONO* CO-COUNSEL**

***Pro Bono* Counsel for Mr. Prosper Mugiraneza**

1. Pursuant to Rule 31(B) of the Rules of Procedure and Evidence of the International Residual Mechanism for Criminal Tribunals (“Rules” and “Mechanism”, respectively), I respectfully notify the President that the Registry has recognised Ms. Elsa Wyllie to act as *pro bono* co-counsel to Mr. Prosper Mugiraneza in relation to the ongoing relocation matter, as of 13 May 2026. I recall that Ms. Kate Gibson was recognised as *pro bono* counsel to Mr. Mugiraneza as of 4 November 2015 for compensation proceedings before the Mechanism. Upon the conclusion of these proceedings, Ms. Gibson continued to represent Mr. Mugiraneza in relation to the ongoing relocation matter.¹ Her recognition remains in effect, and Ms. Wyllie will serve as *pro bono* co-counsel.
2. The Registry’s recognition follows vetting of Ms. Wyllie’s qualifications to act as *pro bono* counsel before the Mechanism, the submission of a Power of Attorney signed by Mr. Mugiraneza, dated 31 March 2026, and an Undertaking executed by Ms. Wyllie on 30 March 2026.
3. I note that the recognition of *pro bono* co-counsel does not entail appointment or assignment pursuant to Rule 42 or 43 of the Rules.
4. I remain available should the President require further information.
