I. INTRODUCTION

1. On 22 April 2025, the Registrar of the International Residual Mechanism for Criminal Tribunals (“Mechanism”) appointed me as Monitor¹ to observe and report on the progress of contempt proceedings against Mr. Vojislav Šešelj, Mr. Miljan Damjanović, Mr. Miroljub Ignjatović, Ms. Ljiljana Mihajlović, and Mr. Ognjen Mihajlović (“Accused”), referred to the Republic of Serbia (“Serbia”) by a Single Judge pursuant to Articles 1(4), 6(2), and 6(4) of the Statute of the Mechanism and Rule 14 of the Mechanism’s Rules of Procedure and Evidence.²
2. This Twelfth Monitoring Report, which I respectfully submit to the President through the Registrar in accordance with the applicable Terms of Reference,³ covers the period from 21 July to 18 September 2026.

II. PROCEDURAL HISTORY

3. The First Monitoring Report outlined the relevant procedural history of this case, from the indictment of the Accused through the referral of the case to Serbia, up until 20 November 2024.⁴
4. Subsequent Monitoring Reports discussed the monitoring activities undertaken between 20 November 2024 and 21 May 2026.⁵

5. The Eleventh Monitoring Report covered the period from 22 May to 20 July 2026.⁶

III. REPORT

6. At the time of submission of this Twelfth Monitoring Report, no updated information is available regarding the status of the *Šešelj et al.* case in Serbia.
7. Since the submission of the Eleventh Monitoring Report, I have received no response to my numerous inquiries addressed to the Ministry of Justice of Serbia (“Ministry of Justice”).
8. Following the holiday period, on 9 September 2026, I again contacted the Assistant Minister in the Sector for International Cooperation and Strategic Planning at the Ministry of Justice, requesting information on the status of the preliminary assessment in the *Šešelj et al.* case. I also asked about the possibility of arranging a (video) call to discuss the matter.
9. I reiterated my request for information, *via* e-mail, on 16 September 2026. To date, I have not received a response.
10. Based on information previously received, the *Šešelj et al.* case is still awaiting a preliminary opinion of the Ministry of Justice.
11. I remain available to provide any additional information.
