I, GRACIELA GATTI SANTANA, President of the International Residual Mechanism for Criminal Tribunals (“President” and “Mechanism”, respectively);

NOTING that, on 22 February 2012, a trial chamber of the International Criminal Tribunal for Rwanda referred the case against Mr. Fulgence Kayishema (“Kayishema”) to the authorities of the Republic of Rwanda (“Rwanda”) for trial before the High Court of Rwanda;¹

NOTING that, on 29 October 2025, the Trial Chamber of the Mechanism assigned in the case of *Prosecutor v. Fulgence Kayishema*, Case No. MICT-12-23 (“Trial Chamber”), issued a decision dismissing, *inter alia*, three of the four grounds submitted by Kayishema in support of his request to revoke the referral of his case and that, on 24 December 2025, the Trial Chamber also dismissed the fourth ground put forward by Kayishema (collectively, “Impugned Decisions”);²

NOTING that, on 8 January 2026, Kayishema filed a notice of appeal against the Impugned Decisions;³

RECALLING that, on 15 January 2026, I assigned, pursuant to Article 12(3) of the Statute of the Mechanism (“Statute”), a bench of the Appeals Chamber to consider the Notice of Appeal (“Appeals Chamber”), composed of: myself as Presiding Judge, Judge Carmel Agius, Judge Florence Rita Arrey, Judge Liu Daqun, and Judge Seon Ki Park;⁴

RECALLING that, on 10 February 2026, I decided to withdraw from the Appeals Chamber;⁵

RECALLING Article 12(3) of the Statute;

PURSUANT TO Rules 23(A) and 24(B) of the Rules of Procedure and Evidence of the Mechanism;

HEREBY ASSIGN, effective immediately, Judge Seymour Panton to the Appeals Chamber; and

ORDER, effective immediately, that the Appeals Chamber shall therefore be composed as follows:


