I, VAGN JOENSEN, Judge of the International Residual Mechanism for Criminal Tribunals (“Mechanism”) and the Single Judge in this case;<sup>1</sup>

**NOTING** that, following the arrests of Maximilien Turinabo, Anselme Nzabonimpa, Jean de Dieu Ndagijimana, Marie Rose Fatuma, and Dick Prudence Munyeshuli in the Republic of Rwanda on 3 September 2018, the Accused were transferred to the United Nations Detention Facility (“UNDF”) in Arusha, United Republic of Tanzania on 11 September 2018;

**NOTING** the initial appearances of the Accused on 13 September 2018 and that each remain detained in the UNDF;

**RECALLING** the status conferences held on 13 December 2018 and 14 March 2019;


**RECALLING** that, pursuant to Rule 69(A) of the Rules of Procedure and Evidence (“Rules”), a status conference shall be convened within, *inter alia*, 120 days after the last status conference to organize exchanges between the parties, review the status of the case, and to allow the accused the opportunity to raise issues in relation thereto, including their mental and physical condition;

**PURSUANT** to Rule 69(A) of the Rules;

**HEREBY SCHEDULE** a status conference on Tuesday, 4 June 2019 at 2.30 p.m. in the Courtroom of the Arusha Branch of the Mechanism.
