

ENFORCEMENT OF SENTENCES



as of August 2019

On 1 July 2012 and 1 July 2013, the International Residual Mechanism for Criminal Tribunals (“Mechanism”) took over responsibility for the supervision of all sentences pronounced by the International Criminal Tribunal for Rwanda (“ICTR”) and the International Criminal Tribunal for the former Yugoslavia (“ICTY”), respectively.

Individuals convicted of crimes by the ICTR, the ICTY, or the Mechanism do not serve their sentences in the United Nations detention facilities in Arusha or The Hague but in UN Member States that have concluded enforcement agreements with the United Nations for sentences pronounced by the ICTR, the ICTY, or the Mechanism.

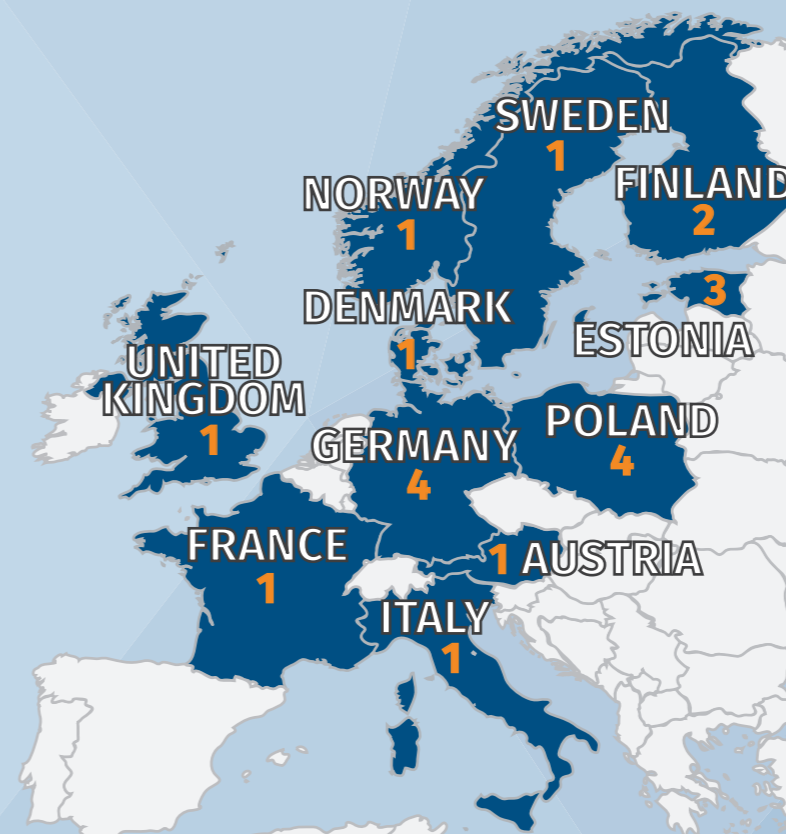
The Mechanism ensures that these sentences are enforced in accordance with international standards of detention and the applicable law of the enforcing State.

The President of the Mechanism is responsible for designating the State of enforcement, supervising the enforcement of sentences, and deciding on requests for pardon, commutation of sentence, or early release.

In addition to those individuals identified here, there is one individual awaiting transfer to an enforcement State following a conviction entered by the ICTR and four individuals awaiting transfer to an enforcement State following convictions entered by the ICTY or the Mechanism.

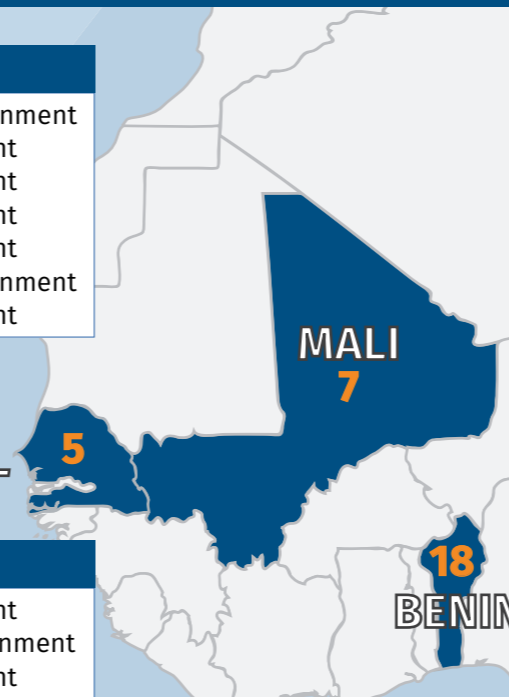
