Organizational setting and Reporting:

This position is located in the General Services Section, Registry, under the direct supervision of the Project Manager and alternate OIC of the Facilities Management Unit (FMU).

Responsibilities:

- Operate/maintain distributed building equipment/systems.
- Performs daily inspections of major building equipment and regularly surveys/inspects all workspaces including: Electrical power distribution system, Central HVAC system, Water/Fire pumps control system, Generator ATS backup system, UPS system, and Firefighting equipment, Plumbing system, Elevators, and Solar power system. Prepares and completes preventive maintenance schedules and reports.
- Prepares requisitions for maintenance supplies. Assists in identifying potential vendors, Performs regular repair, reconditioning and preventive maintenance work. Performs regular plumbing and electrical repairs, performs basic office equipment repairs (i.e. shredders etc.). Performs welding, forming and fabrication of metals.
- Undertakes minor construction and repairs. Installs partitions, changes locks, and replaces glass.
- Evaluates the extent of repairs required. Assists in preparation of plans and specifications for work requirements.
- Provides direction to outside contractors and ensures that construction and repair projects are completed in accordance with requirements.
- Prepares status of work completed.
- Any other ad-hoc duties.

cause offence or humiliation, when such conduct interferes with work, is made a condition of employment or creates an intimidating, hostile or offensive work environment, and when the gravity of the conduct warrants the termination of the perpetrator's working relationship.
