### **Organizational setting and Reporting:**

The Individual Contractor will be working in the Medical Unit of the International Residual Mechanism for Criminal Tribunals (IRMCT), Arusha Branch. The incumbent will work under the general supervision of Medical Officer.

Only candidates under consideration will be contacted. The selected candidate will be offered a contract as an Individual Contractor.

### **Term of Reference for Consultant**

#### **Work Location:**

Arusha

#### **Expected duration:**

Six (6) months with possibility of up to three (3) month extension.

#### **Delivery:**

The IC will be called when required and in the absence of the Medical Officer.

### **Duties and Responsibilities:**

- Performs day-to-day clinical duties, e.g., attending to the IRMCT clinic.
- Be on call during and outside office hours to respond to emergencies in line with international protocols such as advanced cardiac life support or Pre-Hospital Trauma life support, as and when required.
- Refers patients and follow up with outside specialists.
- Conducts pre-placement and periodic examinations.
- Provides health education, wellness screening check-up and participates in addressing work environment and occupational health.
- Prepares staff for travelling, including providing immunizations and travel advice.
- Recommends medical evacuations when required and follows the United Nations established policies and procedures regarding medical evacuations and sick leave.
- Ensures proper record of medical information and exercise confidentiality.
- Responsible for establishing good relations with reliable hospitals and private medical facilities and blood banks and local physicians.
- Ensures that medical equipment first aid kits and other medical supplies are replenished and kept in stock.
- Performs other medical and administrative duties considered necessary by the Medical Officer.

### **Qualifications/ special skills:**

Education: Doctorate (MD) or equivalent in medicine, including residency/internship in one of the medical specialties, preferably internal medicine is required. Must be registered with Medical Council of Tanganyika. Certificates in Advanced Cardiac Life Support (ACLS) and/or Advanced Trauma Life Certificate or Pre-Hospital Trauma Life Support is an advantage.

**Experience:** Minimum of 7 years of progressively responsible experience in the medical field or related area is required. Experience working within the United Nations common system or International Organization is highly desirable.

**Language:** English and French are the working languages of the IRMCT. For this position, fluency in English is required. Working knowledge of French is desirable. Knowledge of Swahili is an asset.

**Fee for Service:** depending upon experience, fee will range from \$52 to \$75 per hour.

## United Nations Considerations
