Organizational setting and Reporting:

This position is located at the United Nations Detention Facility ("UNDF"), International Residual Mechanism for Criminal Tribunals ("Mechanism"). Under the overall command of the Commanding Officer UNDF and the direct supervision of the Logistics Officer UNDF, the incumbent will provide support to UNDF

Responsibilities:

- Prepare three daily meals for detainees;
- Prepare the menu and ensure that the food items take into account the age, health conditions and cultural habits of the detainees;
- Monitor the food stocks;
- Verify the food quality purchased;
- · Perform any other duties as required.

Core Competencies:

Candidates who have committed crimes other than minor traffic offences may not be considered for employment.
